Should your Bright33 fixture prove to be defective in material or workmanship under normal use during the duration outlined below, effective from the original purchase date, Bright33 will replace defective unit as outlined below.

PRODUCT WARRANTY

If the product supplied by Bright33 fails due to defects in material or workmanship within the first three (3) years of purchase date by the ORIGINAL PURCHASER, Bright33 will replace the defective unit free of charge. This warranty covers defects in manufacturing discovered while using the product as recommended by the manufacturer.

PRODUCT FINISH WARRANTY

The finish material is warranted for a period of one (1) year. This warranty covers defects in manufacturing discovered while using the product as recommended by the manufacturer.
